- 2 The school is required to submit the land certificate which was shown during review and affidavit sent by school through email in regard of classrooms and sections, in the compliance within 03 months.
- 3 The school is required to install the lift to access all of the upper floors with the provision laid in RPWD Act and Board's guidelines (https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf) within 03 months and submit the compliance.
- 4 The school is required to make the website functional and maintain mandatory public disclosure as per appendix - X at home page with distinct icon within 03 months and submit the compliance.
- 5 The school shall conduct training of its teachers with CoE Dehradun within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.
